TRASH COLLECTION & RECYCLING PROGRAM GUIDELINES

1. Newville Borough Council has approved participation in a joint municipal trash collection and recycling program with Southampton Township, Penn Township, Cooke Township, North Newton Township, South Newton Township and Shippensburg Township. Southampton Township serves as the coordinating municipality. Bills for trash collection and recycling services will be issued by Southampton Township. Customers will be responsible to pay Southampton Township for their trash collection service. The collection of delinquent trash collection and recycling accounts will be the responsibility of Southampton Township.
2. Landlords shall be responsible for providing trash collection services to their tenants.
3. Trash and recycling totes will be provided by the contractor, Apple Valley Waste, LLC. Participants shall be provided with a 90-99 gallon trash tote and a 64 gallon tote for recycling. Trash and recycling containers are provided at no cost to the customer.
4. Single stream recycling will be utilized. This means that customers may place all forms of approved recyclable materials in their recycling container provided by the company for weekly collection. Please see definitions for more information regarding approved recyclable items. Please note, due to changes in the recycling markets, the list of acceptable recyclables is subject to change. Apple Valley Waste LLC has provide a listing of approved recyclables.
5. Bag customers are not eligible for the bulk pickup & recycling programs. If they want to include recycling, they must pay the extra fee
6. All full service customers may place one bulk item for collection on a weekly basis. Please see definitions for more information regarding acceptable bulk items. Large bulk item collection requires advance registration with Apple Valley Waste, LLC by calling (717) 532-7685 to arrange for the bulk item pickup. Large bulk items does not include appliances (White Goods)
7. Participants in the trash bag program must purchase bags in minimum lots of twelve (12) trash bags. Participants may dispose up to three (3) thirty-three (33) gallon trash bags each week. For each trash bag, AVW asks that it does not exceed 35 pounds in weight.
8. Residents of Newville Borough will have their trash and recyclables collected on THURSDAY of each week. Trash, recyclables and bulk items may not be placed out for collection until after 4:00PM on the day prior to collection. Trash totes and recycling containers must be removed from the collection route by 7:00PM on the day of collection. Apple Valley Waste LLC reserves the right to alter collection dates due to weather conditions.

DEFINITIONS:

TRASH/GARBAGE: Shall include all matter and materials which are discarded or rejected by the owners or producers thereof as offensive or useless, or which by their presence or accumulation may injuriously affect the health, comfort or safety of the citizens of Newville Borough. It shall include garbage, rubbish, trash and other refuse materials, but shall exclude human body waste, medical waste, hazardous waste, debris from household renovations both interior and exterior, dirt, rock, concrete, lead pipe, tree limbs, tree trunks and stumps, white goods, batteries, paint, tires and all form of vegetation.

RECYCLABLES: Please refer to the Park's Guidelines for Recycling. Please note, Apple Valley Waste LLC reserves the right to accept or reject recyclables placed for collection due to contamination, and the company may also amend as required the list of approved recyclable items.

BULK ITEMS: Shall include anything that does not fit into a regular trash bag must be called in to be scheduled.
Unacceptable materials: White goods, construction waste, batteries, tires, paint and hazardous materials.
