ISO (Insurance **Services Organization**)

Good news!! The ISO conducted an evaluation of the fire departments servicing the Shippensburg area. The review collects and evaluates information from communities across the US on their structure fire suppression capabilities. ISO takes the information and provides a **Public Protection** Classification (PPC) grade assigned to the communities. Insurance companies use the PPC grade to calculate insurance costs to homeowners. Vigilant Hose scored a 03/3X, which is better than the 2017 score of 4/8B. This helps keep your homeowner's insurance lower. STCC would like to thank the men and women of Vigilant Hose for all their hard work keeping us safe.
