All work done shall comply with the Subdivision and Land Development Article VII "Driveway Regulations of the Southampton Township Code."		
The road surface is proved to the width of _____ Feet (minimum width of 10' and maximum width of 24')		
All driveways shall be constructed in such a manner as not to impair drainage within the road right of way.		

1. All driveways, adjacent areas, and areas between such driveways including, but not limited to, channelization, paving, and drainage, shall be located, designed, and constructed in such a manner as to be consistent and compatible with the design, maintenance, and drainage of the Township Roadway and shall incorporate into the driveway design and mode of construction elements that will accomplish this compatibility. No driveway may interfere with or be inconsistent with the design, maintenance, and drainage of the Township Roadway. (Article VII 295-704 of the Southampton Code.)
2. To enable vehicles to turn around before entering the highway, a "loop" or T" must be constructed to facilitate the vehicle turning around.
