HOPEWELL TOWNSHIP BOARD OF SUPERVISORS, CUMBERLAND COUNTY, HAS ELECTED TO PARTICIPATE IN SOUTHAMPTON TOWNSHIP, CUMBERLAND COUNTY’S SOLID WASTE COLLECTION PROGRAM. EFFECTIVE NOVEMBER 1, 2022. THIS PROGRAM ALLOWS PARKS GARBAGE SERVICES TO PERFORM GARBAGE COLLECTION SERVICES FOR ALL RESIDENTIAL CUSTOMERS WITHIN HOPEWELL TOWNSHIP - CUMBERLAND COUNTY. BUSINESSES WITH COMMERCIAL GARBAGE COLLECTIONS WILL NOT BE INCLUDED IN THIS PROGRAM.

QUARTERLY INVOICES WILL BE ISSUED BY SOUTHAMPTON TOWNSHIP, CUMBERLAND COUNTY. INVOICES MUST BE PAID BY THE DUE DATE SPECIFIED ON THE BILL. RATES ARE AS FOLLOWS:

**All accounts must be set up in the property/homeowner’s name. All bills will be mailed to the property owner/(landlord). Bills are the responsibility of the property owner. Accounts will NOT be set up under a renter’s name.**

**Past Due Accounts: A \$50.00 reinstatement fee will be assessed to restart service for trash accounts that were terminated for non-payment. The resident/owner signing this form shall be responsible for paying any/all fees associated with the Trash Collection and Recycling Program.**
